In 3-5 year cycle, we are currently creating conditions for these discussions to happen:

- Math – change SLOs
 - Dental Health – Farhad
 - Art – Change SLOs so we could talk across studio lab classes, reduce from 14 to much fewer, systematic,
 - Some SLOs are suffering more than others (equity-based) – studio time is key 25%-50%; advocating for more time
 - Business – hybrid vs online (SLOs) –reflection data – did you notice? Notice – SS data,
 - English – nothing changed
 - Badging (Business)
 - Are there examples of informal assessment of PSLOs that might be helpful? Health sciences may have some
- In those areas where assessment may be falling behind, what is the college doing to complete the assessments per the college’s schedule. Evidence: Provide evidence to support the information and narrative described above.
